Availability: Widely available-around 2 million labor population surrounding Poipet


Trainability: Existing Japanese factories operating in Poipet highly evaluate the workforce quality

WHY POIPET PP SEZ?

BASIC INFRASTRUCTURE

Electricity

- Dedicated transmission line from national grid
- Joint venture company with B. Grimm Power from Thailand provides high quality power distribution service.
- 1,000kVA stand-by backup generator.

Water supply

- Underground water capacity 980 m³/day
- Water treatment capacity 2,000 m³/day

Waste water treatment plant

- Treatment Capacity 1,610 m³/day

Flood mitigation

- Zone is surrounded by dike

LAND PRICE & UTILITY COST

- Industrial land with 50 years lease: **USD 50/m²**
- Water: **KHR 2,000/m³ (about USD 0.5)**
- Sewage treatment: **USD 0.46/m³**
(based on 80% of purchase water volume)
- Electricity: **USD 0.137/Kwh**
- Infrastructure maintenance: **USD 0.06/m²/month (+10% VAT)**
- Standard rental factory: **USD 3.5/m²/month (+10% VAT)**
